SUPPORT FOR STAFF AND STUDENTS

- Continued work on creating a guaranteed and viable curriculum through teacher collaboration amongst grade levels and departments

- Focused professional learning support for staff based on the district's initiatives and staff's needs

CREATING 'SOCIAL JUSTICE LEADERS FOR CHANGE' IN MICHIGAN SCHOOLS

As social justice, diversity, equity, and inclusion continue to be a priority for LCS, we have had approximately 26 staff members participate in justice leaders courses and/or responsive teaching courses through the WISD.

We were also awarded the opportunity to be a part of MASA's "Beyond Equity" – their newest professional learning program to build a better education system for all students. A district team will engage in the 18-month collaborative SDEI (Social Justice through Diversity, Equity and Inclusion) series focused on real issues, lived experiences, and district transformation, and is anchored around student voice and activism. MASA's Beyond Equity program – which includes small and large group discussions; structured exercises and protocols; reading, videos, and reflective journaling; group presentations to share learning and implementation plans; and more – is split into four key phases:

Phase 1: Inside SDEI

Phase 2: Equity Assessment and Transformation Audit

Phase 3: Building a District SDEI Plan

Phase 4: Implementing a District SDEI Plan

Lincoln is excited to be a part of this learning as we continue to deepen our understanding of social justice, diversity, equity and inclusion and move our district forward in this work.

SOCIAL-EMOTIONAL LEARNING (SEL) PILOT GRANT

Social-Emotional Learning is part of MDE's Michigan Integrated Continuous Improvement Process (MICIP) and focuses on not just the academics, but the whole child. Lincoln Consolidated Schools understands the importance of the social and emotional well-being of our students and staff. Due to this, we applied for a grant and were awarded the District-Wide SEL Pilot grant sponsored by MDE. This sixteen-month Pilot (in which a district team of various stakeholders will participate) will support us in our exploration of how to scale up SEL from a building to a district. The District-Wide SEL Pilot goals are:

- Scale up SEL from one or some buildings to every building in the district
- Strengthen the SEL efforts within the districts
- Adhere to the core components of CASEL's five SEL competencies
- Begin with Adult SEL before providing explicit SEL instruction to students
- Ensure that equity is inseparable from the five SEL competencies
- · Commit to an infrastructure to support and sustain SEL
- Align SEL practice with the CASEL district-wide rubric

Our district will end the pilot better prepared to take the work to full implementation.

SCHOOLS VACCINES REQUIRED FOR SCHOOL ENTRY IN MICHIGAN

Whenever children are brought into group settings, there is a chance for diseases to spread. Students must follow state vaccine laws in order to attend school. These laws are the minimum standard to help prevent disease outbreaks in school settings. The best way to protect students in your care from other serious diseases is to promote the recommended vaccination schedule at www.cdc.gov/vaccines. Encourage parents to follow GDC's recommended schedule; by doing so, school requirements will be met.

If your family lives in any of the following situations:

- In a shelter, motel, vehicle, or campground
- On the street
- In an abandoned building, trailer, or other inadequate accommodations, or



Doubled up with friends or relatives because you cannot find or afford housing you need

to know that preschool and school-aged children have certain rights or protections under the McKinney-Vento Homeless Education Assistance Act.

You have the right to:

- Go to school, no matter where you live or how long you have lived there. You must be given access to the same public education provided to other students.
- Continue in the school you attended before you became homeless or the school you last attended, if that is your choice and is feasible.
- Receive transportation to the school you attended before you became homeless or the school you last attended, if you request such transportation.
- Enroll in school without giving a permanent address.
 Schools cannot require proof of residency that might prevent or delay school enrollment.
- Enroll and attend classes while the school arranges for the transfer of school and immunization records or any other documents required for enrollment.
- Enroll and attend classes in the school of your choice even while the school and you seek to resolve a dispute over enrollment.
- Receive the same special programs and services, if needed, as provided to all other students served in these programs.
- Receive transportation to school and to school programs.

When you move, you should do the following:

- Contact the school district's local liaison for homeless education at 734-484-7070 for help in enrolling your child in a new school or arranging for your child to continue in his or her former school. (Or, someone at a shelter, social services office, or the school can direct you to the person you need to contact.)
- Contact the school and provide any information you think will assist the teachers in helping your child adjust to new circumstances.
- Ask the local liaison for homeless education, the shelter provider, or a social worker for assistance with clothing and supplies, if needed.

BOARD POLICY 9130: PUBLIC COMPLAINTS

(See full Board Policy at www.lincolnk12. org)

Any person or group, having a legitimate interest in the operations of this District shall have the right to present a request, suggestion, or complaint concerning District personnel, the program, or the operations of the District. At the same time, the Board of Education has a duty to protect its staff from unnecessary harassment. It is the intent of this policy to provide the means for judging each public complaint in a fair and impartial manner and to seek a remedy where appropriate.

It is the desire of the Board to rectify any misunderstandings between the public and the District by direct discussions of an informal type among the interested parties. It is only when such informal meetings fail to resolve the differences, shall more formal procedures be employed.

Any requests, suggestions, or complaints reaching the Board, Board members, and the administration shall be referred to the Superintendent for consideration.

Problem Solving: A Two-Way Process

Get Started

- Establish your goal.
- Agree to discussion guidelines.
 - Listen without interrupting.
 - Be honest in your discussions.

Listen and Define the Concern

- What is the problem or concern?
- Is there more than one perspective from which to view the problem?
- Is the information each person has about the problem accurate?

Identify Solutions

- Each person suggests at least one solution to the problem.
- All parties evaluate each possible solution:
 - Can all parties agree with the solution?
 - Is everyone committed to working on the suggested solution?
 - Will the solution work now and in the future?
 - Is everyone willing to share equal responsibility for making the solution work?
 - Does the solution tell who, when and how?

Move Forward

- Agree upon a proposed solution and the role each party will have in implementing it.
- Set a date for checking in with each other.

LINCOLN EARLY CHILDHOOD SERVICES

The Lincoln Early Childhood Center, located in Model Elementary School, offers a range of comprehensive services for children from birth through age five. The center utilizes a model that emphasizes that parents are a child's first, best, and most influential teachers.

The Early Childhood Center includes classrooms for the Great Start Readiness Program, Early Childhood Special Education, and Lincoln's Early On Program. The goal of the center is to establish a primary prevention community available to families living in the Lincoln community. Through strong parental involvement, the Early Childhood Center is an avenue promoting the improved social, cognitive, and physical growth of young children in our community.

Pre-School

Lincoln offers two different pre-school programs. Students for these programs must be three years old by September 1st and reside in the Lincoln School District. Great Start Readiness Program (GSRP) is a grant-funded pre-school program. Eligibility for this program is based on household income and a child's "risk factors." Welcome back to Lincoln Consolidated Schools for the 2021-2022 school year! For student safety, we do not publicly publish school bus route information. Families who complete the Request for Transportation will be notified of their bus route information prior to the start of school.

REQUEST FOR STUDENT TRANSPORTATION

Lincoln Consolidated Schools requires a completed Request for Student Transportation form for each student (with the exception of ECSE & GSRP) needing school bus transportation to reserve a seat on the bus. To request transportation for your child(ren), complete the online form

(available online at www.lincolnk12.org) for each

student.



Bus Transportation will only be assigned for students who have a completed request form on file. Students without an assigned bus will not be allowed to ride the bus. Families will be notified of their bus route information via robocall and email prior to the start of school.



BUS RIDERSHIP PROGRAM

Transportation is adding new technology to increase safety and manage the routing. Each student riding the bus will be given new transportation ID badge that they will need to scan on and off the bus daily. There is also a new parent software application for your devices to track the buses location individualized for your students. We understand that anything new will take some time to get into a routine and we will help you with the new processes.

KINDERGARTEN STUDENTS

There MUST be a parent or guardian at the bus stop daily to receive your kindergarten student from the bus. We will not leave a kindergarten student at a bus stop without a parent or guardian present.

The transportation webpage will be updated frequently with any information that you may need, so please look there throughout the year for more information.

TALK: TEXT AND LEARN FOR KINDERGARTEN

Parents and caregivers can sign up to receive text messages offering simple activities to improve their children's literacy. The statewide service, called TALK (Text and Learn for Kindergarten), sends two text messages a week suggesting activities that parents and caregivers can easily incorporate into daily routines with their children.

Parents may sign up by texting **TALK to 75547 or visiting texttolearn.com**. The texts are available in English or Spanish.

Each message begins with one of the five early literacy practices and details an activity parents can use to help their child develop early literacy skills, which are reading, singing, talking, writing, and playing. The texts

go beyond literacy and help parents build other important skills such as premath and social emotional skills. The more parents and caregivers talk and listen to young children, the easier it is for them to learn to read and write when they start kindergarten. This is because simple activities such as singing and playing every day help kids develop the cognitive and language skills they need to do well in school.

TALK is available to parents and caregivers in Michigan with children ages 5 years and younger.



PERSONAL CURRICULUM ALTERNATIVE

Generally, to earn a high school diploma, a student must satisfy the requirements of Michigan's Merit Curriculum. The District may modify those requirements, however, by developing a personal curriculum for a student. All students are entitled to a personal curriculum.

A parent or quardian of a student who has completed ninth grade (or the student if at least 18 years old or emancipated), or a student's teacher or counselor, may request a personal curriculum by contacting the High School Principal. A group that includes the student; the student's parent or guardian; and a teacher, guidance counselor, or person acting in a counseling role, will consider the request If the personal curriculum request is made by a student who is at least 18 or who is emancipated, or by a parent or guardian, the group will grant the request and will develop a personal curriculum for the student. For all other requests, the group will develop a personal curriculum if the group determines one is appropriate. For most students, the group that develops the personal curriculum may make only certain modifications to the Merit Curriculum.

For students with disabilities under the Individuals with Disabilities Education Act and for certain students transferring to the District from a nonpublic school or from out of state, the group may make additional modifications. For all students, a personal curriculum must incorporate as much of the Michigan Merit Curriculum content expectations as is practicable for the student, must include measurable goals for the student to achieve while in high school, must include a method to evaluate whether the student met those goals, and must align with the student's educational development plan.

Before a personal curriculum becomes effective, the High School Principal and the student's parent or guardian (or the student if at least 18 or emancipated) must agree to its terms. Once effective, the student's parent or guardian (or the student if at least 18 or emancipated) must communicate with each of the student's teachers to monitor the student's progress on the personal curriculum goals. A student who successfully satisfies his or her personal curriculum may earn a high school diploma even if the student does not otherwise satisfy all of the Michigan Merit Curriculum requirements.

INTEGRATED PEST MANAGEMENT NOTIFICATION

State of Michigan law requires that schools and day care centers that may apply pesticides on school or day care property must provide an annual advisory to parents or guardians of students attending the facility.

Please be advised that Lincoln Consolidated Schools utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, you will receive advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide, or herbicide, other than a bait or gel formulation, that is made to the school or day care grounds or buildings during this school year. Please note that notification is not given for the use of sanitizers, germicides, disinfectants, or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Advance notification of pesticide applications, other than a bait or gel formulation, will be given by at least 48 hours to the application by the following two methods. The first method will be by posting at the main entrance to your school/day care center. The second method will be posting in a public, common area of the school or day care center, other than an entrance. We will post in your school's Main Office. Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management Program and records of any pesticide application upon request

Please be advised that parents or guardians of children attending the school or day care center are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least 3 days before the pesticide application, if they so request If you prefer to receive the notification by first class mail, please contact your building/program administrator for a form and return it to our office.

Each year the Lincoln Consolidated School District is required to give notice of the various rights accorded to parents or students pursuant to the Family Educational Rights and Privacy Act ("FERPA"). - 2. RIGHT TO REQUEST AMENDMENT: You have the right to seek to have corrected any parts of an education record which you believe to be inaccurate, misleading or otherwise in violation of your rights. This right includes the right to a hearing to present evidence that the record should be changed if a designated official of the Lincoln Consolidated School District decides not to alter the education records according to your request If no change is made to the education record after the hearing, you have a right to place a written rebuttal in the record
- 3. RIGHT TO PREVENT DISCLOSURES: You have the right to prevent disclosure of education records to third parties with certain limited exceptions. It is the intent of the Board of Education to limit the disclosure of information contained in your education records to those instances when prior written consent has been given to the disclosure, as an item of directory information of which you have not refused to permit disclosure, or under the provisions of FERPA which allow disclosure without prior written consent.



BRICK'S POLLINATOR GARDEN PROJECT


